 - Non-market participant MBOS selection/allocation: likely future work—flag for later to avoid scope creep; consider benefit-sharing concepts to prevent imbalance.
 - Avoid tying the TF's critical path to market operators; integrate with markets without depending on them.
 - iii. Non-market Participant allocation/selection of MBOS
 - Cadence / whether to pause

- o General preference to keep momentum: continue high-level redlines and maintain meeting cadence.
- Focus on "low-hanging fruit" and a prioritized list of edits; deeper EDAM specifics could wait until there's more clarity (~Nov 1 target).
- Near-Term Plan (through Oct 9)
 - Deliver revised Concept Paper for RAPC endorsement on Oct 9.
 - o Identify redlines that can be completed in the next month; use shorter, focused sessions to close them.
- Action Items
 - o Michael: Draft narrative framing (diversity sharing / education) for the paper.
 - o Produce a prioritized redline list; mark items to defer (e.g., EDAM deep dives).
- 3. Next steps on developing the Proposal
 - Timeline: Finalize proposal by end of December; WPP to begin feasibility review and advance to PRC.
 - Owners: Michael/WPP to prioritize edits and lead redlines.
 - Sequence: Draft Tariff language first, then update the BPMs.
