### Meeting Agenda

#### 1. Proposal Endorsement

##### Summary of Discussion

- Task Force reviewed final proposal redlines and recent edits.
- Agreed to move previously removed language on material participation changes into the Risk section of the proposal.
- Other minor clarifying edits to the risk section were accepted.
- Consensus that the proposal, as amended during the meeting, reflects a complete Task Force product.

##### Motion & Outcome

- **Motion:** Move the Task Force proposal forward to **public comment**.
- Clarified that:
  - This motion indicates the proposal is **ready to advance to public comment only**, not that all Task Force members fully support every element.
  - Individual participants retain the ability to comment during public comment.
- **Vote:**
  - No opposition to moving the proposal to public comment.
  - Task Force will recommend to the PRC that the proposal is complete and ready for release.

### Key Timeline Decisions

- Task Force recommended a 4-week public comment period:
  - Provides sufficient time for meaningful input.
  - Preserves schedule flexibility to reach the June Board meeting.
- Expectation that Task Force may meet weekly during the post-comment update window, depending on comment volume.
- Goal is to deliver a near-final proposal by mid-April to allow adequate review by PRC, RAPC, COSR, and Board.

### Closing

- WPP will:
  - Highlight amendments made during this meeting for PRC review.
  - Include targeted public comment questions, including identified risks.
  - Place calendar holds for potential Task Force meetings during the comment-response period.
- Task Force members expressed appreciation for the collaborative process and staff support.
- Proposal now advances to PRC approval to public comment.
