- » Messaging tailored to specific audience types (utilities, state regulators, etc.)


#### » Risk Considerations

#### **WestTEC Tribal Transmission Updates**

·In October, the Affiliated Tribes of Northwest Indians (ATNI) hosted their Midyear Annual Convention at the Suquamish Tribal homelands, during the ATNI Energy Committee there was a resolution supporting an ad hoc Energy Regulatory Taskforce which was passed at this gathering.

- · At the National Congress of American Indians (NCAI) 82nd Annual Convention, November 17th 21st at Seattle, Washington, which was also the largest NCAI gathering with over 3,000 attendees, there was an ATNI resolution titled "Studying and advancing Tribal needs for electric grid modernization", that was passed onto a National platform as an NCAI resolution.
- Also, in November FTL Consulting was honored to share the stage with WestTEC leaderships Sarah Edmonds, at the Al Clean Energy Summit in Portland, Oregon we both spoke on a panel on Al and grid modernization integration. It was a well-attended, network-building event with extremely robust discussions on the Pacific Northwest, Al integration, and the Clean Energy intersection.
- The Western Tribal Transmission Workgroup (WTTW) has had Bonneville Power Administration (BPA) join discussions last week at our weekly information sessions, and this week on Friday December 12th we will be hosting Federal Energy Regulatory Commission (FERC) staff attending our meeting and gaining an overview of FERC, its processes, and their current Tribal outreach initiatives.
- · FTL Consulting will be joining an interview for the WestTEC 10-year study, and a perspective of engaging with WestTEC throughout this Transmission planning process.
- FTL Consulting is continuing engagement with California Independent System Operator (CAISO) on their Tribal engagement process which has been a great opportunity to work with Danielle Mills, Jeffery Billington, and their amazing CAISO staff.
